### 6. Accidental Release Measures

<b>Spills</b>	Vacuum first if possible or wet then sweep up and place in waste containers.
<b>Precautions for Clean-Up Crew</b>	Avoid creating excessive dust. Wear Class P1 or P2 respirator.

### 7. Handling and Storage

<b>Storage</b>	Store in a dry well-ventilated environment fully protected from the weather.
<b>Handling</b>	Use safe work practices to avoid eye and skin contact and inhalation.

### 8. Personal Protection

#### Exposure Standards

- ▶ Calcium Carbonate: 10 mg/m<sup>3</sup> TWA (time weighted average) as inhalable dust
- ▶ Gypsum (Calcium Sulphate): 10 mg/m<sup>3</sup> TWA as inhalable dust
- ▶ Dust NOS (not otherwise specified): 10 mg/m<sup>3</sup> TWA as inhalable dust

#### Engineering Controls

Avoid generating dust. If dust is created when using power operated equipment for cutting or drilling the product in an enclosed or poorly ventilated area local dust extraction is recommended. Work areas should be cleaned regularly by sweeping or vacuuming.

#### Personal Protective Equipment

If dust is generated, use Class P1 which conforms to AS/NZS 1715 and 1716.  
Note: Persons with facial hair will be unable to obtain a satisfactory face seal.  
Use rubber gloves to avoid skin contact if product causes irritation.  
Wear goggles if dust is likely to cause irritation.
